**INVITATION TO BID
FOR THE SECURITY MANPOWER SERVICES CONTRACT FOR SEC DAVAO EXTENSION
OFFICE FOR THREE (3) YEARS**

The Securities and Exchange Commission (SEC), through the General Appropriations Act (GAA), intends to apply the sum of **One Million One Hundred Twenty Thousand Pesos (Php 1,120,000.00) per year** being the Approved Budget for the Contract (ABC) chargeable against SEC-GOP funds in payment for the **Service Contract Agreement for the Security Services**. The contract duration is for three (3) years. Bids received in excess of the ABC shall be automatically rejected during the bids opening.

SEC now invites bids for the **Supply of Services for the above-mentioned project**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from the BAC Secretariat, and purchase the Bidding Documents at the **Securities and Exchange Commission – Davao Extension Office, 3rd Floor, AMYA 2 Building, Quimpo Blvd., Davao City** starting **February 1, 2012** upon payment of a non-refundable fee for the Bidding Documents in the amount of Three Thousand Pesos (Php 3,000.00).

SEC will hold a **Pre-Bid Conference on February 8, 2012, 10:00 A.M.** at the **Securities and Exchange Commission – Davao Extension Office, Conference Room 3rd Floor, AMYA 2 Building, Quimpo Blvd., Davao City**, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the **Securities and Exchange Commission – Davao Extension Office, Conference Room 3rd Floor, AMYA 2 Building, Quimpo Blvd., Davao City on or before February 20, 2012 at 10:00 A.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause no. 18**.

Bids opening shall be held on **February 20, 2012 at 10:00 A.M.** at the **Securities and Exchange Commission – Davao Extension Office, Conference Room 3rd Floor, AMYA 2 Building, Quimpo Blvd., Davao City**. Bids will be opened in the presence of the Bidders' representatives. Late bids shall not be accepted.

The SEC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
