**SUPPLY OF MATERIALS, LABOR, EQUIPMENTS AND TECHNICAL EXPERTISE FOR THE CONSTRUCTION OF A (3) THREE STOREY BUILDING OF SEC DAVAO EXTENSION OFFICE**

The Securities and Exchange Commission (SEC), through its General Appropriations Act of 2012 (continuing), intends to apply the sum of **Twenty Seven Million Two Hundred Ninety One Thousand Six Hundred Sixteen Pesos (Php27,291,616.00)**, being the Approved Budget for the Contract (ABC) in payment for the **Supply of Materials, Labor, Equipments and Technical Expertise for the Construction of a (3) three Storey Building of SEC Davao Extension Office**. Bids received in excess of the ABC shall be automatically rejected during bid opening.

SEC now invites contractors to bid for the **Supply of Materials, Labor, Equipments and Technical Expertise on the above-mentioned construction project**. The **Project Duration is (8) eight months**. Bidders should have completed a similar contract to the project costing at least 75% of ABC within the period of ten (10) years from date of submission and receipt of bids.

Bidding will be conducted through open competitive bidding procedure using the non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

To bid for the contract, a contractor must submit a Letter of Intent (LOI) with certificate of good standing from SEC and/or DTI, DOLE, BIR, SSS and other regulatory agencies (if applicable), purchase bid documents and must meet the following major criteria: (a) Filipino citizens/sole proprietorships, partnerships, or organizations at least seventy five (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and (b) with valid PCAB License Category of at least “**Category A**” and Registration Classification of at least “**Medium A size range for Building**” (c) Net Financial Contracting Capacity at least equal to ABC, or credit line commitment at least equal to 20% of ABC and (d) have an established office/s within Region 11 for the period of at least **(3) three** years from date of submission and receipt of bids.

Interested bidders may obtain further information from the BAC Secretariat, and may purchase the Bidding Documents at SEC Davao Extension Office (SEC-DEO), 3/F AMYA2 Bldg., Quimpo Blvd., Matina, Davao City starting **September 23, 2013**, upon payment of a non-refundable fee for the Bidding Documents in the amount of **Twenty Five Thousand Pesos (Php 25,000.00)**.

All bids must be accompanied by a Bid Security in any acceptable forms and in the amount stated in ITB clause 18. It will be opened in the presence of the Bidder’s representatives who choose to attend at the address stated above. Late Bids shall not be accepted.

The SEC reserves the right to accept any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
