BAC RESOLUTION NO. 2014- 06

SUBJECT: SUPPLY AND DELIVERY OF VARIOUS PARTS AND CONSUMABLES FOR KODAK PRINTER 7 THROUGH DIRECT CONTRACTING

WHEREAS, the Securities and Exchange Commission, through its Bids and Awards Committee (BAC), intends to procure 2 pieces EP Unit Assembly, 2 units PC Drum and Heater Halogen Lamp for Kodak Printer 7 Machine through Section. 50.c, IRR of R.A. 9184. The Approved Budget for the Contract is Three Hundred Fifty One Thousand Seven Hundred Eighty Nine and 52/100 Pesos (Php 351,789.52);

WHEREAS, Section 50, Rule XVI, Alternative Methods of Procurement, Implementing Rules and Regulations of Republic Act 9184 provides that: *“Direct contracting or single source procurement is a method of procurement of goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the condition of sale. The offer may be accepted immediately or after some negotiations. Direct Contracting may be resorted to by concerned Procuring Entities under any of the following conditions:*

- “a. xxx xxx xxx”*
- “b. xxx xxx xxx”*
- “c. Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP”*

WHEREAS, the BAC reviewed the approved Purchase Request (PR) Nos. 14-03-043 and 14-04-097 dated March 04 and April 23, 2013 respectively, and found that the items are included in the Annual Procurement Plan for CY-2014 under Letter F.2.

WHEREAS, the **Microimaging Sales and Services, Inc.** is the only authorized distributor for Kodak Document Scanners, Kodak Capture Pro Software, Kodak Micrographics and related software accessories and parts (inclusive of the ff: fusing unit and toner kit); and is trained to provide sales and after sales support in the Philippines (See Annex A).

NOW, THEREFORE, on the basis of the foregoing, we, the members of the Bids and Awards Committee, hereby **RESOLVES** to recommend to the SEC Chairperson that the contracts for the above-mentioned project be procured and awarded to **Microimaging Sales and Services, Inc.**, in the amount of Three Hundred Fifty One Thousand Seven Hundred Eighty Nine and 52/100 Pesos (Php 351,789.52).
