INVITATION TO BID

(SEC PB No. 2020-03)

1. The Securities and Exchange Commission (SEC), through the authorized appropriations under the FY-2020 Revised Corporation Code (RCC) intends to apply the sum of **One Million Five Hundred Thousand Pesos (Php1,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Rental of Two (2) Units of Microfilm Reader Printer (without operator)**. Bids received in excess of the ABC shall be automatically rejected during the bids opening.
2. SEC now invites bids for the project **Rental of Two (2) Units of Microfilm Reader Printer (without operator)**. The contract duration is for a **period of one (1) year**. Delivery of the Goods shall be in accordance with Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidder.
3. Bidding will be conducted through open competitive bidding procedure using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA 9184), otherwise known as the “Government Procurement Reform Act”.
4. Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or corporations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
5. Interested Bidders may obtain further information from the BAC Secretariat at the address given below from Monday to Friday at 8:00 a.m. to 5:00 p.m.
6. A complete set of Bidding Document may be acquired by Interested Bidders starting October 30, 2019 from the address below, upon payment of a non-refundable fee of One Thousand Five Hundred Pesos (Php1,500.00).
7. It may also be downloaded free of charge from the Philippine Government Electronic Procurement System (PhilGEPS) and SEC websites, provided that the Bidder shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

The Sec reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
