INVITATION TO BID

The Securities and Exchange Commission (SEC), through its Bids and Awards Committee (BAC), intends to apply the sum of **Two Million and Seventy Thousand Pesos (Php 2,070,000.00)** being the Approved Budget for the Contract (ABC) chargeable against the General Appropriation Act FY 2014 in payment for the **Supply of Goods for the Leasing of 24 Units of Digital Copier Machine for a period of one (1) year.** Bids received in excess of the ABC shall be automatically rejected during the bids opening.

SEC now invites bids for the **Supply of Goods for the above-mentioned project.** Bidders should have completed, within three (3) years prior to the deadline for the submission and opening of bids for this project, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

A complete set of Bidding Document may be acquired by Interested Bidders starting November 17, 2014 from the Procurement Division, 4th Floor, SEC Building, EDSA Greenhills, Mandaluyong City, upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of Two Thousand Five Hundred Pesos (Php 2,500.00).
