Prospective bidders shall accomplish and submit the duly signed Price Quotation Form (Attachment 1) not later than 10:00 A.M. on September 25, 2015 at the Procurement Division, 4<sup>th</sup> floor, SEC Building. Open submission may be submitted, manually or through Facsimile Nos. 584-5330.

Purchaser's Minimum Requirement for the Prospective Bidders:

- 1. Delivery Schedule: Seven (7) calendar days from receipt of approved Work Order
- 2. Bid Validity: Sixty (60) calendar days from submission of bids
- 3. Delivery Site: General Services Division, 4th Floor, SEC Building, Mandaluyong City

The penalty for late deliveries is one tenth (1/10) of one (1) percent of the cost of the unperformed portion from every day of delay. The maximum deduction shall be ten percent (10%) of the contract price. Once the cumulative amount of liquidated damage reaches ten percent (10%) of the contract price, the procuring entity shall rescind the contract without prejudice to other courses of action and remedies open to it.

The SEC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
