BTR plans to borrow in June the same volume offered in May. Treasury bills to be offered every week will raise Php110 billion which includes the Php30 billion for the 35-day bills. Meanwhile, a 3-year and 5-year Treasury bonds amounting to Php30 billion each will also be offered. "We have extended the curve to 3 and 5 years with appetite on this segment for yield pickup. We retained 35-day to provide additional liquidity layer and we are just rolling it over," National Treasurer Rosalia V. de Leon.
