Group A:

(2) Issuer with a class of securities listed for trading in an Exchange;

(3) Public companies or those with total assets of at least Fifty Million Pesos (P50,000,000.00) or such other amount as the Commission shall prescribe, and having two hundred (200) or more stockholders each owning one hundred (100) shares of a class of its equity securities.
